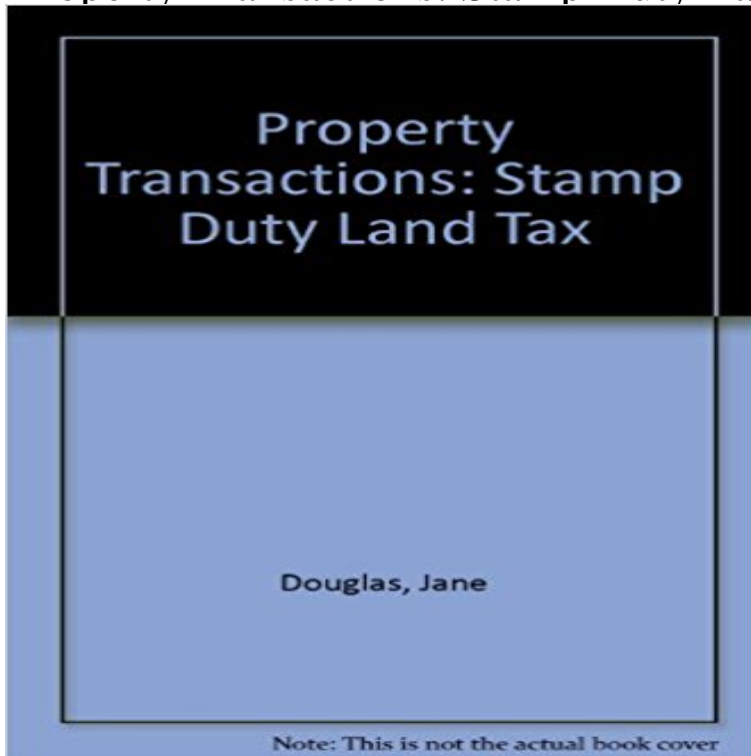


Property Transactions: Stamp Duty Land Tax
