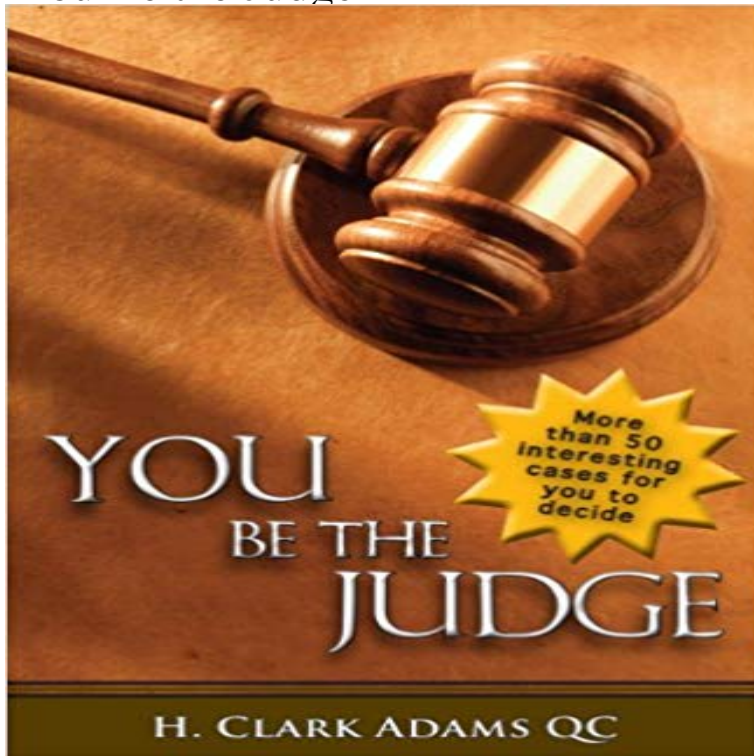


## You Be the Judge
