


# Stop the Violence Against People with Disabilities!: An International Resource



Stop Violence Against Persons with Disabilities! An International Resource provides an international perspective on violence against children and adults with disabilities and promising approaches to risk reduction, intervention, and access to justice when violence does occur. A unique focus of this book is on children and adults who have little or no functional speech as a result of a variety of disabilities. Their voices have been silent too long. As a result of the physical, intellectual, and communication disabilities, these children and adults are especially vulnerable to violence. Additionally, they are often denied access to the criminal justice system.

Throughout the globe, awareness of the scope of the problem is slowly emerging. However, unlike child abuse and elder abuse, the problem of violence against people with disabilities remains largely invisible. The causes of this devastating epidemic are many. Successful approaches to risk reduction are emerging within some countries, but are not widely communicated among and between nations. This book will bring together voices from different nations and varied perspectives so that we can begin to reduce the risk of people with disabilities becoming victims of violence. This grim picture can and will change given the ratification the UN Convention on the Rights of Persons with Disabilities (CRPD). At the time of the writing of this book, 137 countries had ratified this international treaty. Among the 55 articles of the CRPD, two articles apply directly to the topic of violence against people with disabilities and their access to the criminal justice system. Each chapter presents the scope of the problem from the country's experience and will also provide promising practices that have been successful in their country to improve personal safety, communicating and telling, providing

victim services, appearing in court as a witness or expert, successfully trying cases in court, and others. Although the manuscript is written in English, each abstract has been translated into the respective home language of the country and in Easy English. Countries represented in the book are the United States and Canada, the United Kingdom, South Africa, Australia, Israel, and India. The appendix includes a variety of resources. Included are bios of the authors and contact information, The United Nations Conventions on the Rights of People with Disabilities in Easy English, sample Communication Boards in English, Afrikaans, Sepedi, isiZulu, French, Hebrew and Hindi. We are honored that Archbishop Emeritus Desmond Tutu has written the Forward to the book.
