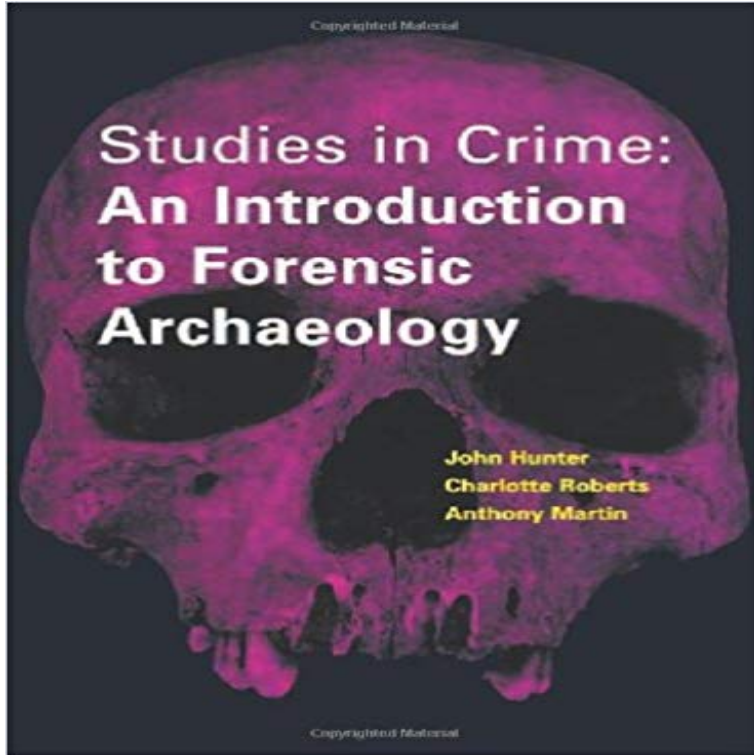


## Studies in Crime: An Introduction to Forensic Archaeology (Batsford)
