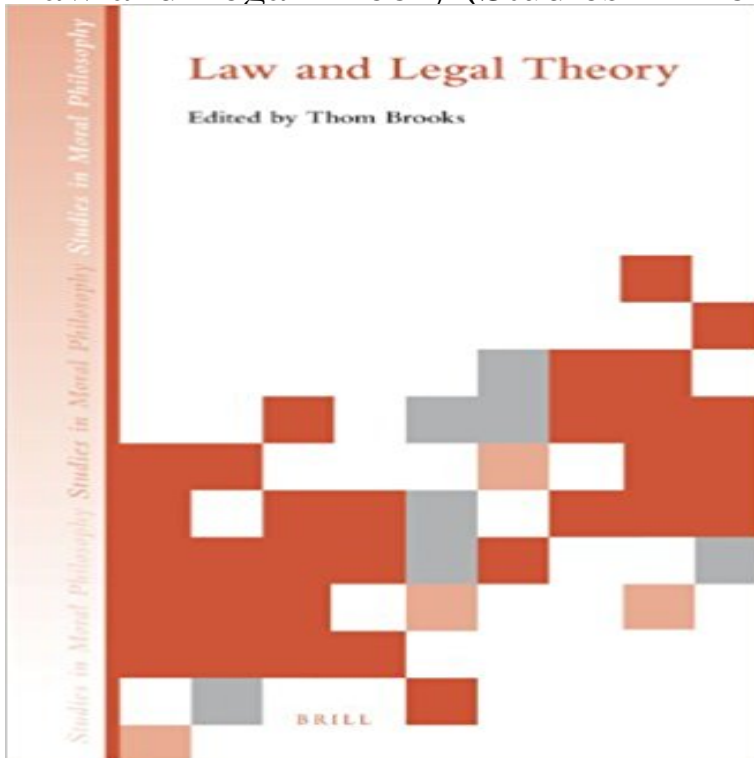


Law and Legal Theory (Studies in Moral Philosophy)
