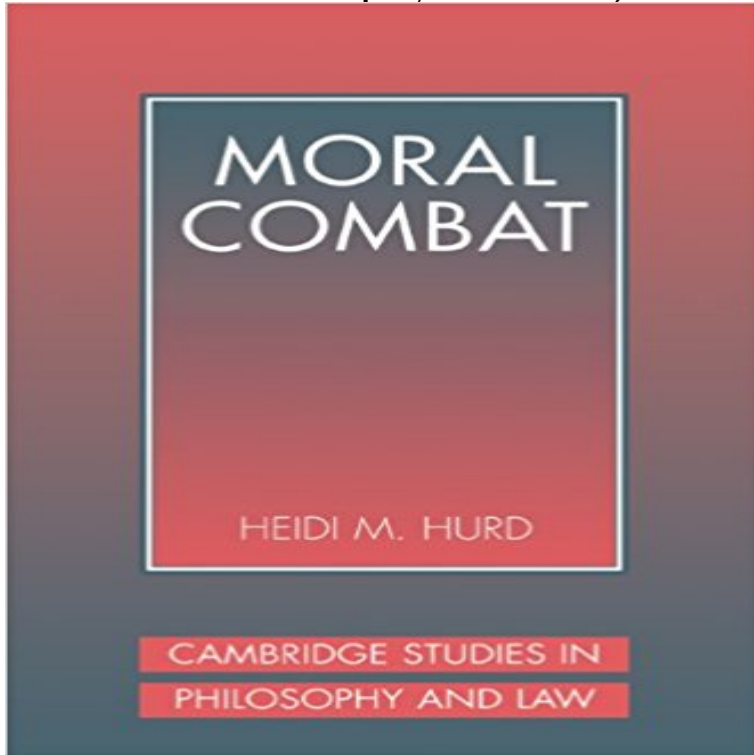


Moral Combat: The Dilemma of Legal Perspectivalism (Cambridge Studies in Philosophy and Law)
