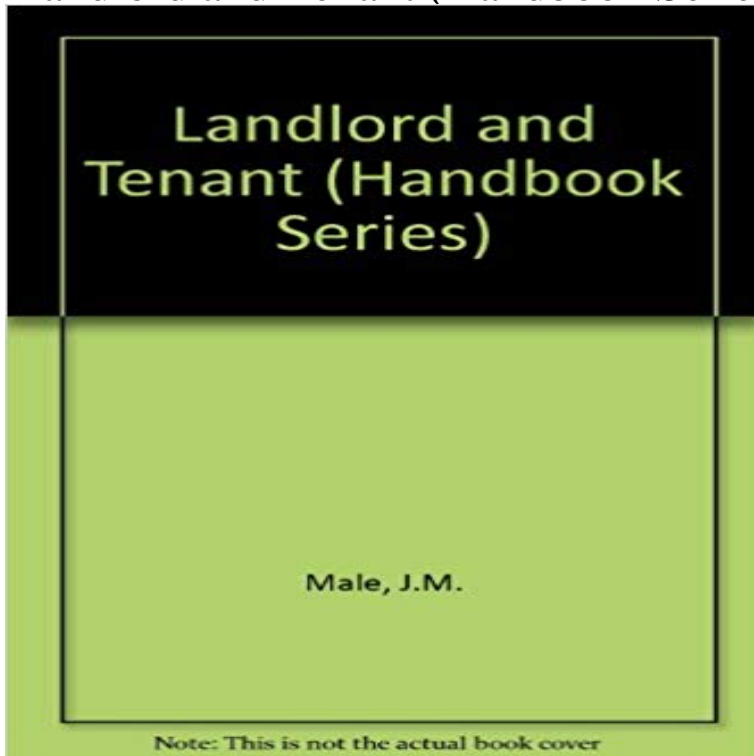


Landlord and Tenant (Handbook Series)
