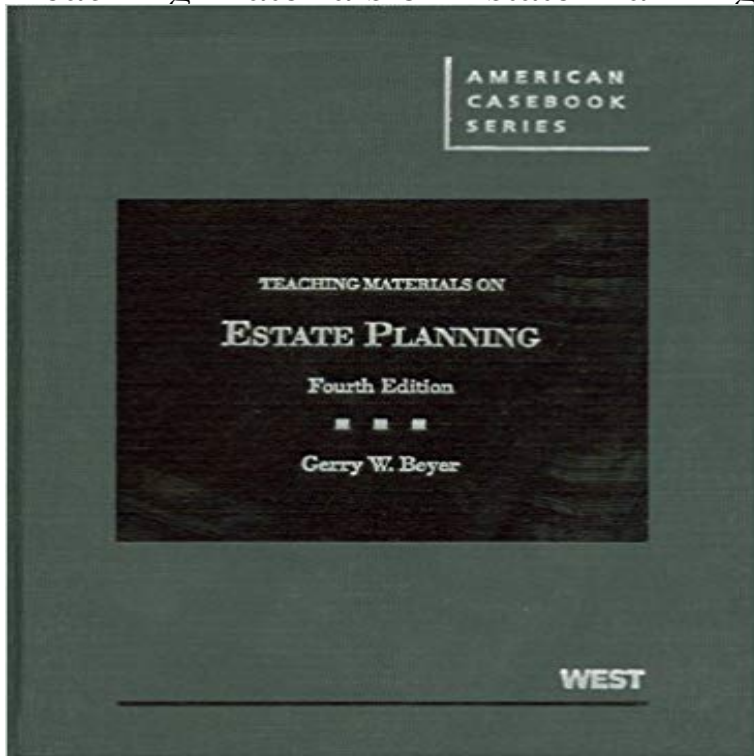


Teaching Materials on Estate Planning (American Casebook Series)
