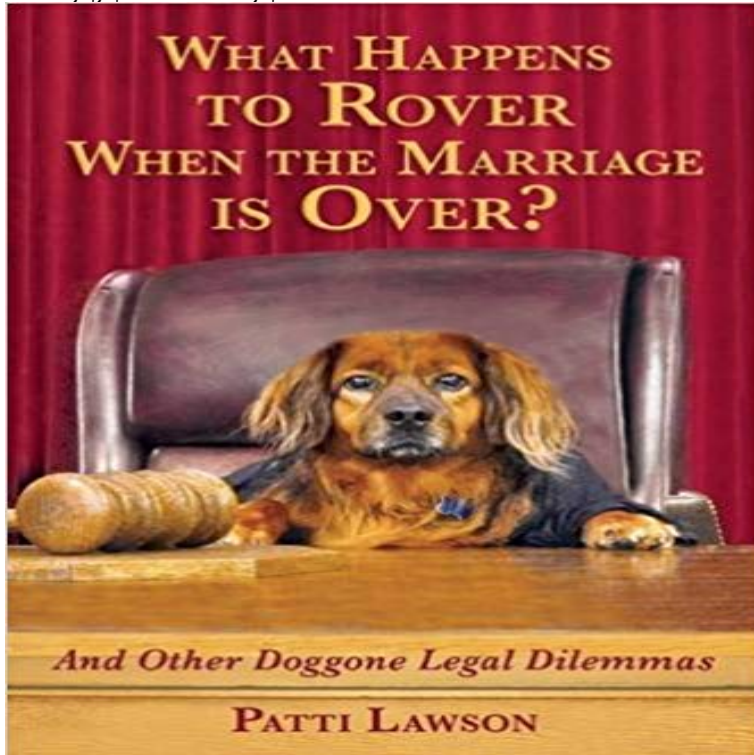


# What Happens to Rover When the Marriage is Over?: And Other Doggone Legal Dilemmas
