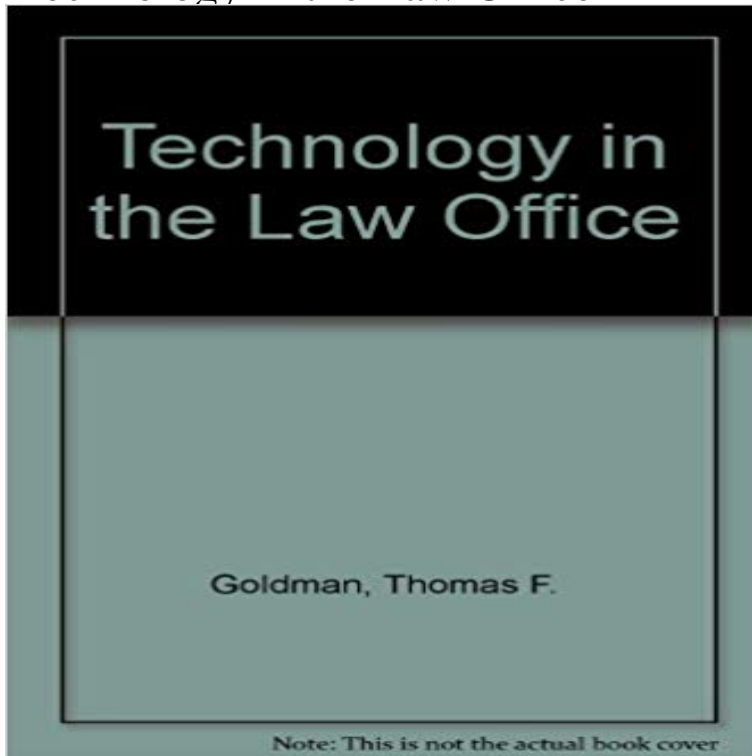


Technology in the Law Office
