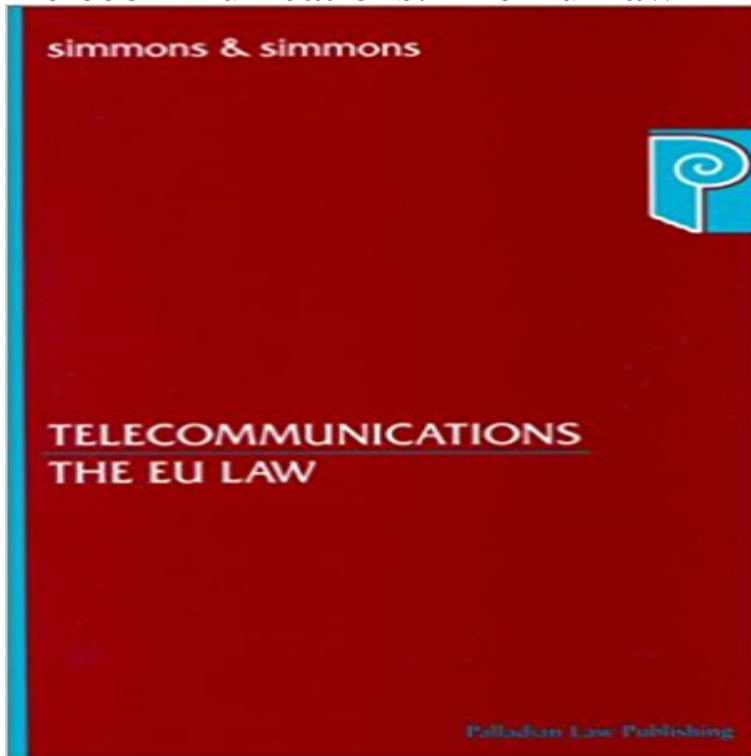


## Telecommunications: The Eu Law
