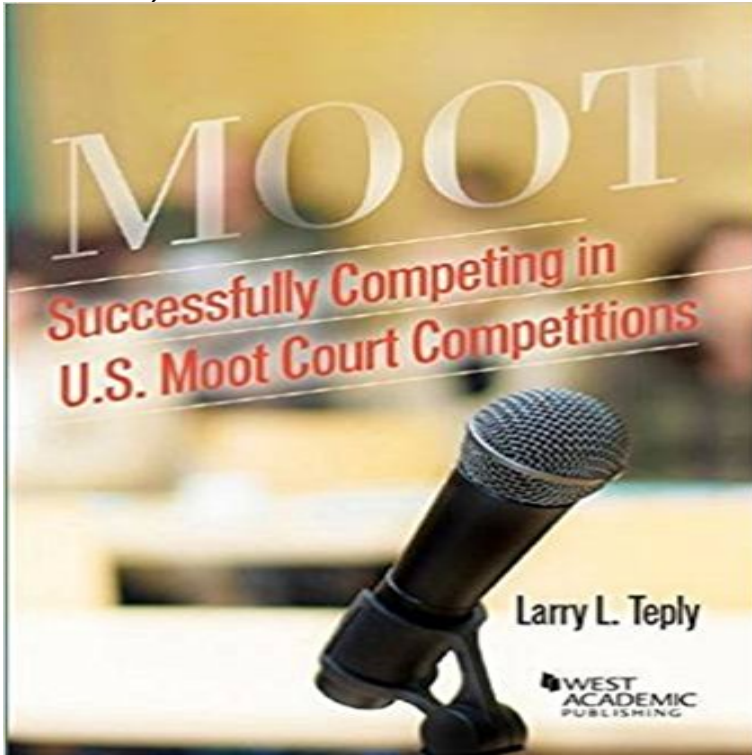


Successfully Competing in U.S. Moot Court Competitions (Career Guides)
