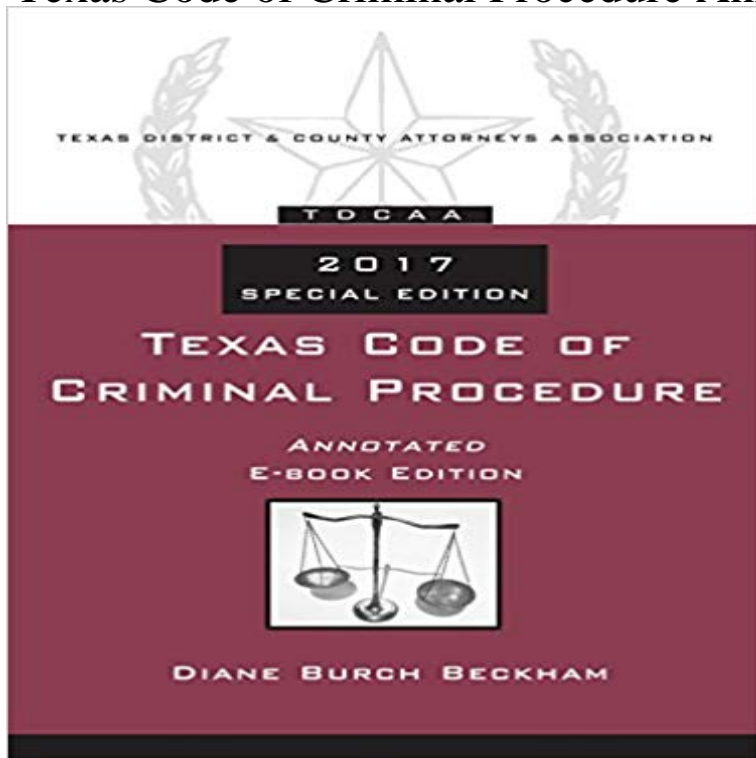


Texas Code of Criminal Procedure Annotated: 2017 Special Edition



This special edition of the Texas Code of Criminal Procedure includes both popular features from code books published in print by the Texas District and County Attorneys Association: case annotations (and practice tips) as well as strikethrough/underline format that shows exactly what changes were made in the 2015 Texas legislative session. This special edition includes changes made to Texas probation laws (via HB 2299) that have renumbered CCP art. 42.12 into a new Chapter 42A. These changes are effective Jan. 1, 2017. Note that this book contains only the Code of Criminal Procedure.
