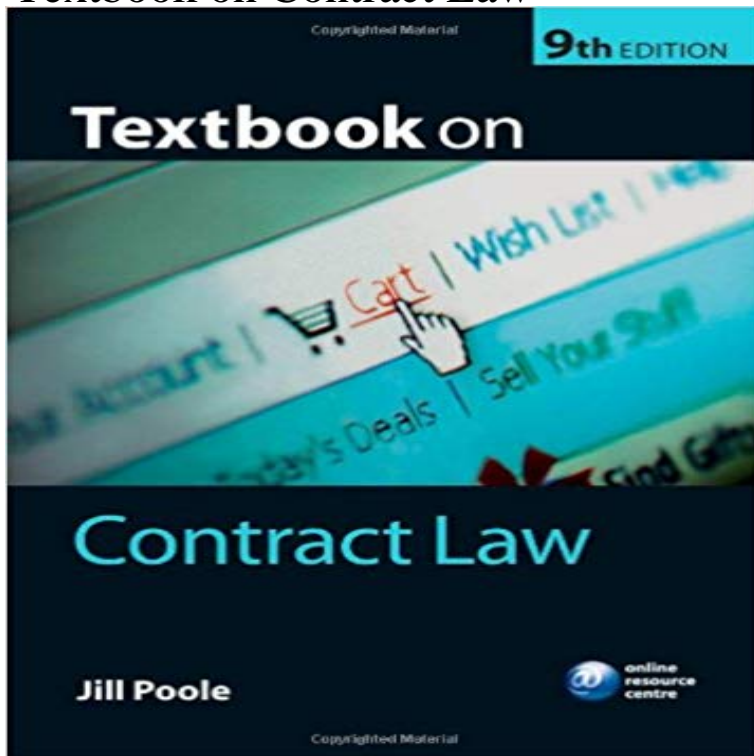


Textbook on Contract Law
