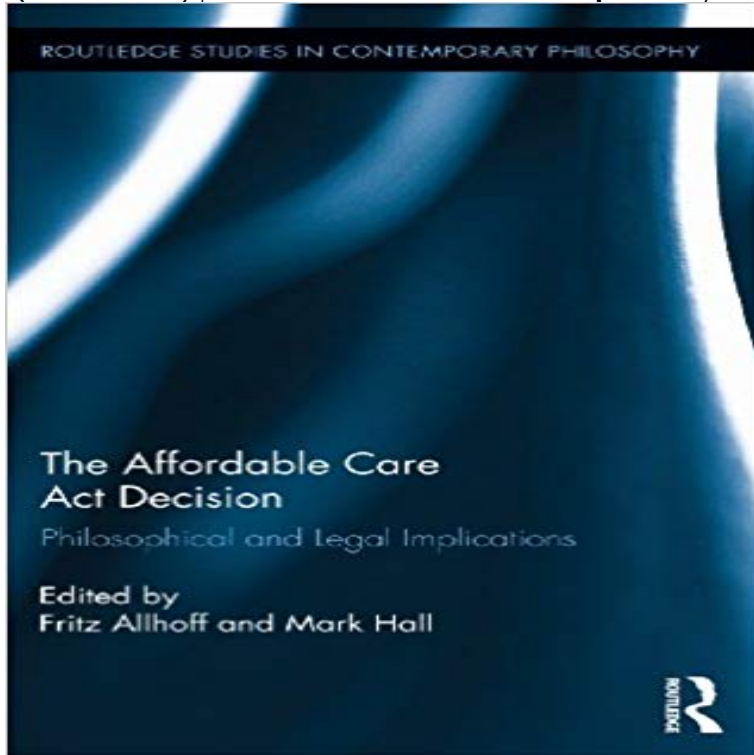


# The Affordable Care Act Decision: Philosophical and Legal Implications (Routledge Studies in Contemporary Philosophy)

Sebelius* has been extraordinarily high, from as soon as the legislation was passed, through lower court rulings, the Supreme Court's grant of certiorari, and the decision itself, both for its substantive holdings and the purported behind-the-scenes dynamics. Essays are divided into five units: context and history, analyzing the opinions, individual liberty, Medicaid, and future implications.
