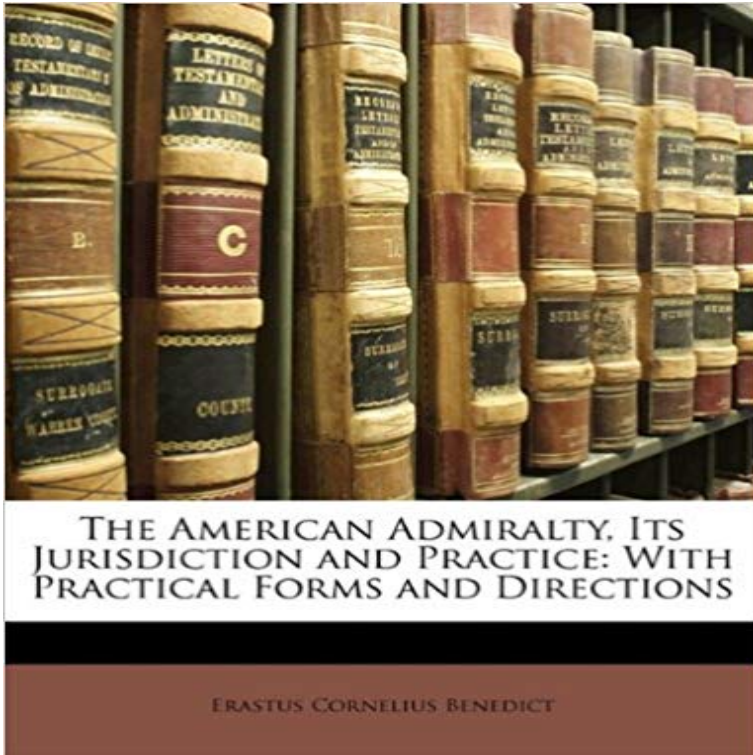


The American Admiralty, Its Jurisdiction and Practice: With Practical Forms and Directions
