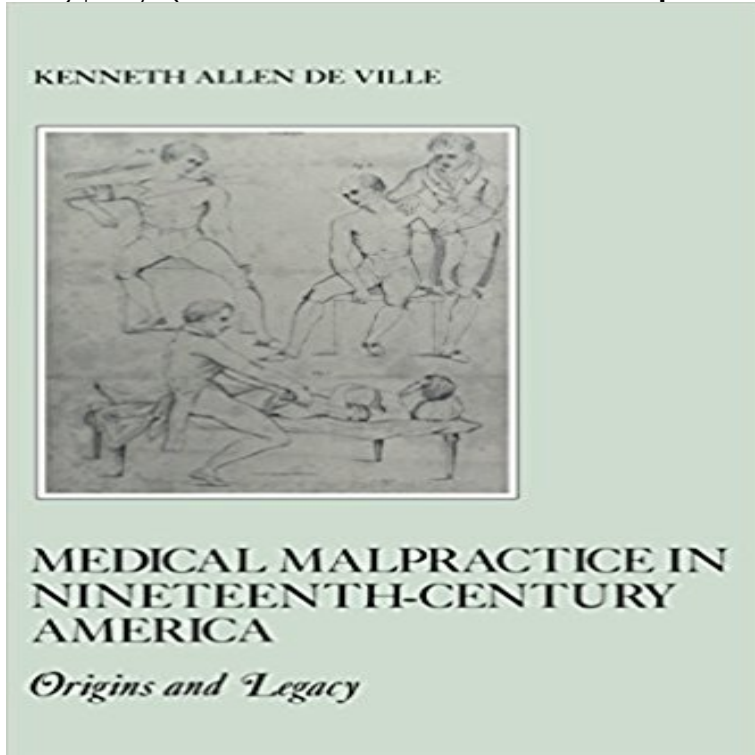


# Medical Malpractice in Nineteenth-Century America: Origins and Legacy (The American Social Experience)
