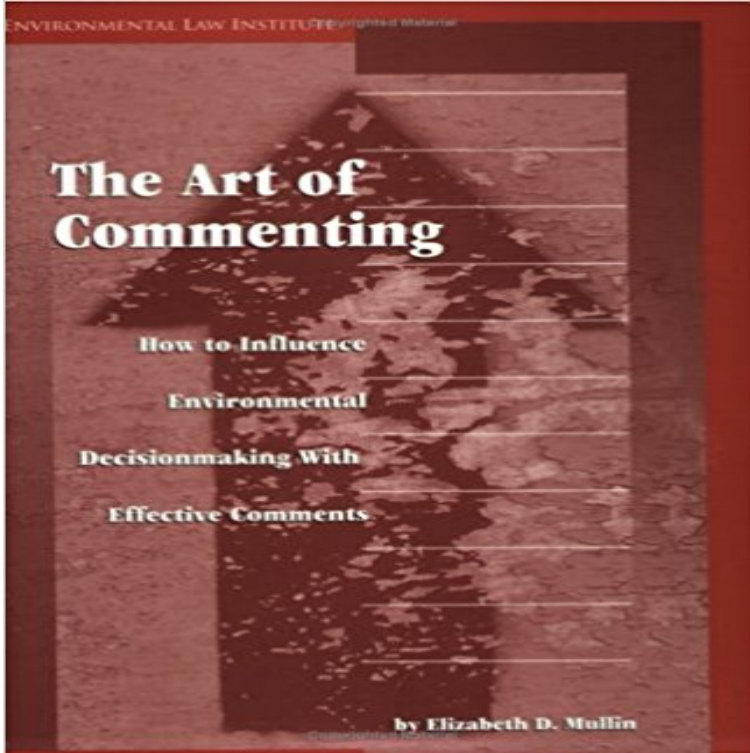


# The Art of Commenting: How to Influence Environmental Decisionmaking with Effective Comments (Environmental Law Institute)
