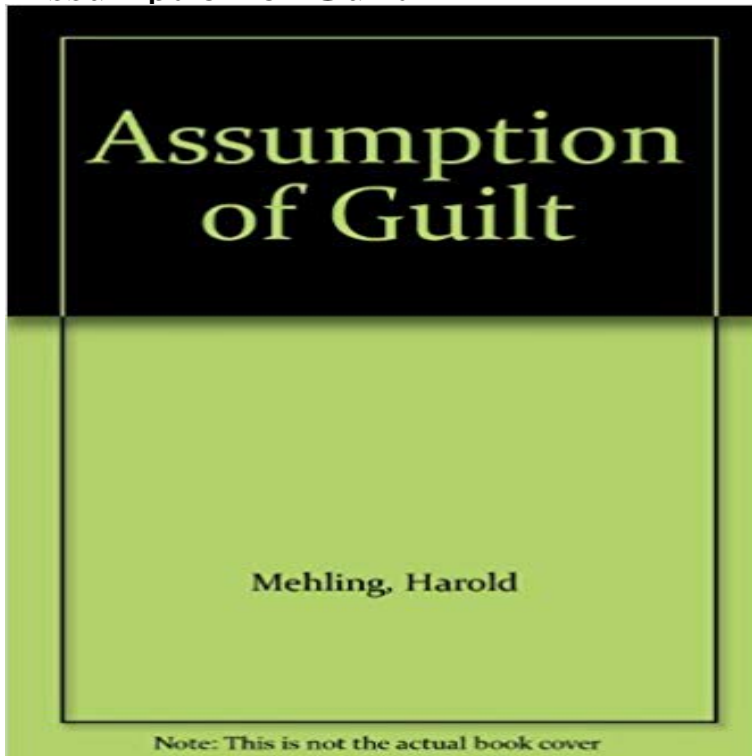


## Assumption of Guilt
