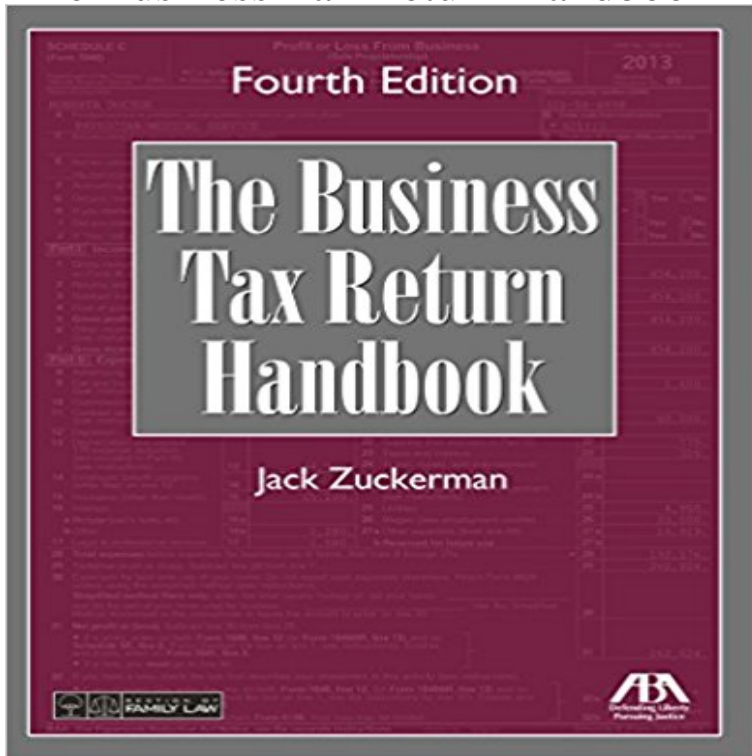


# The Business Tax Return Handbook
