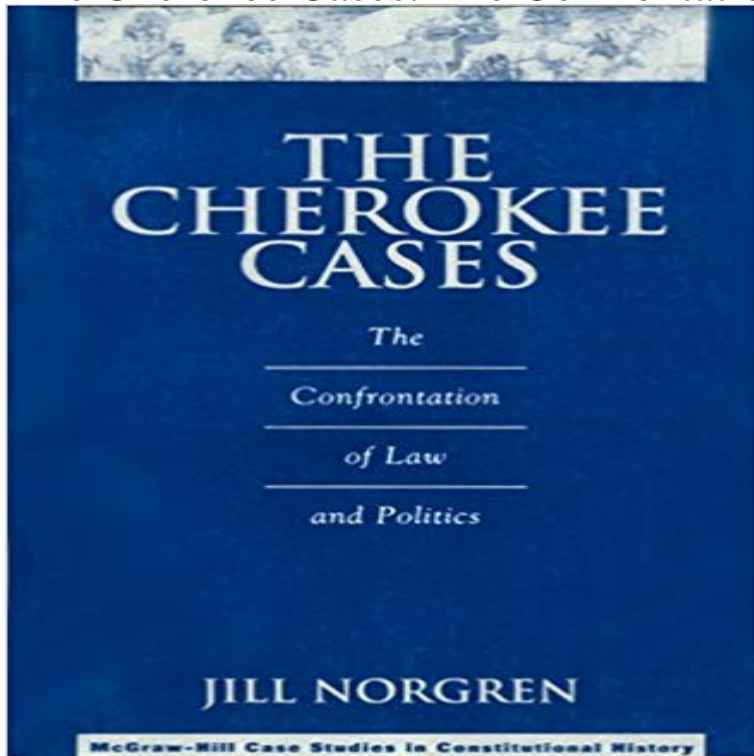


## The Cherokee Cases: The Confrontation of Law and Politics
