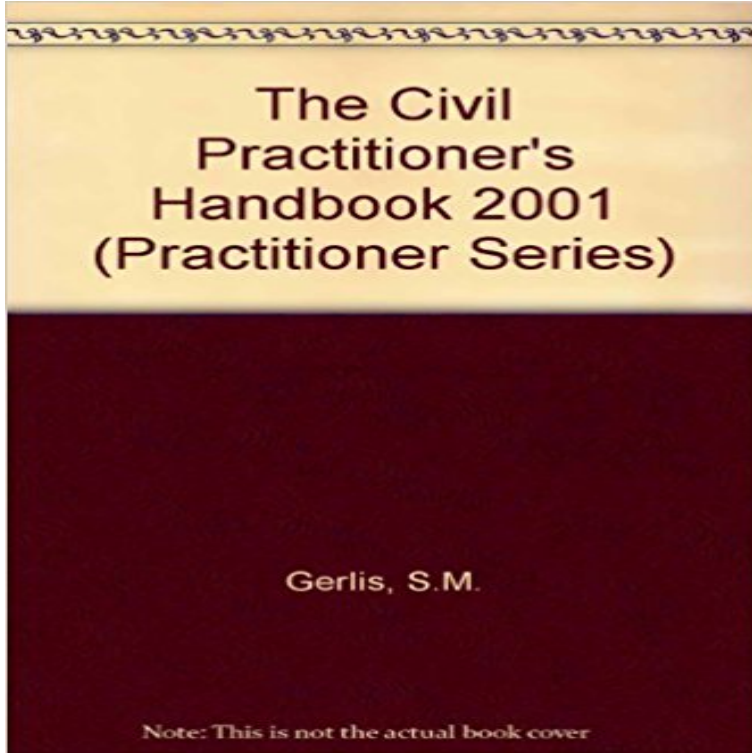


## The Civil Practitioners Handbook 2001 (Practitioner Series)
