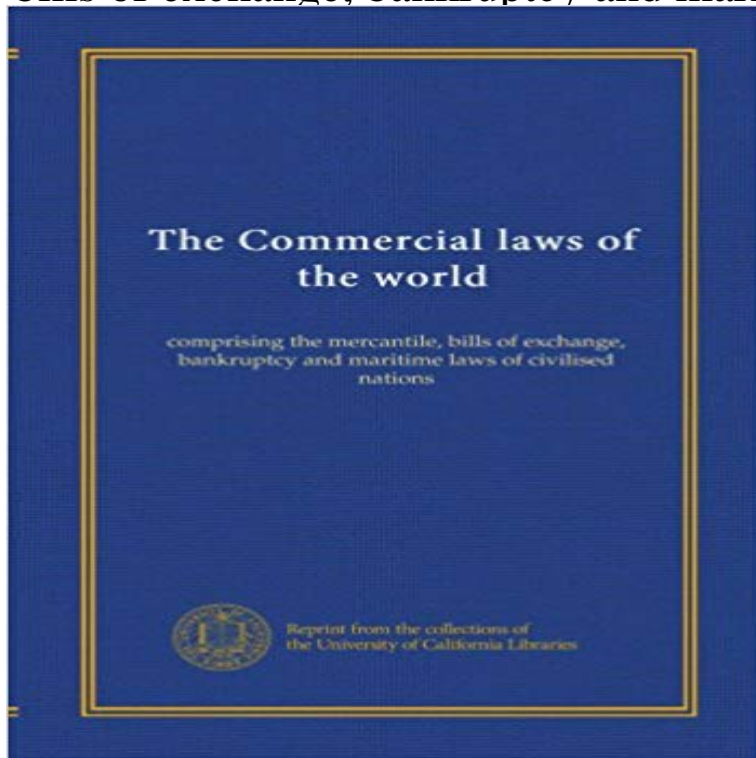


The Commercial laws of the world (v.22): comprising the mercantile, bills of exchange, bankruptcy and maritime laws of civilised nations
