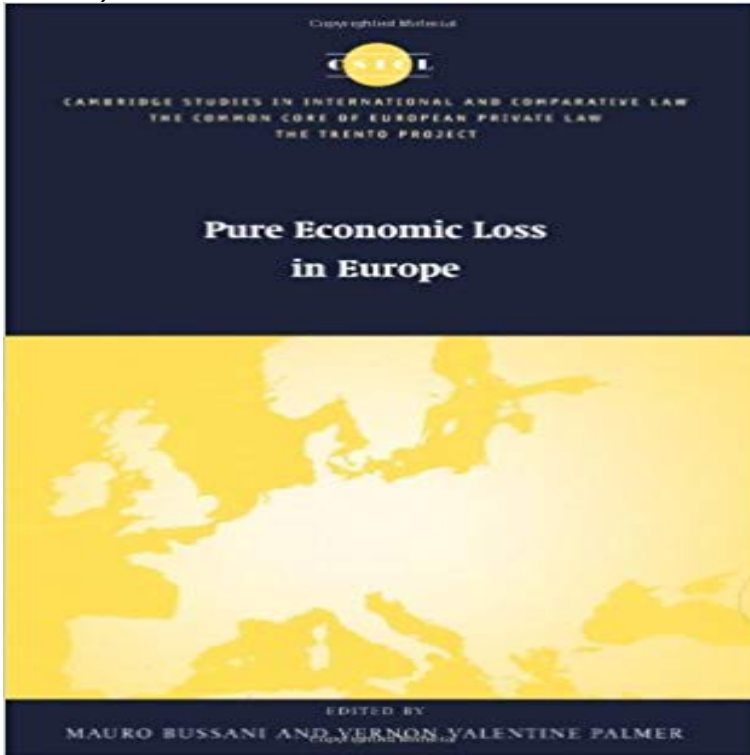


Pure Economic Loss in Europe (The Common Core of European Private Law)
