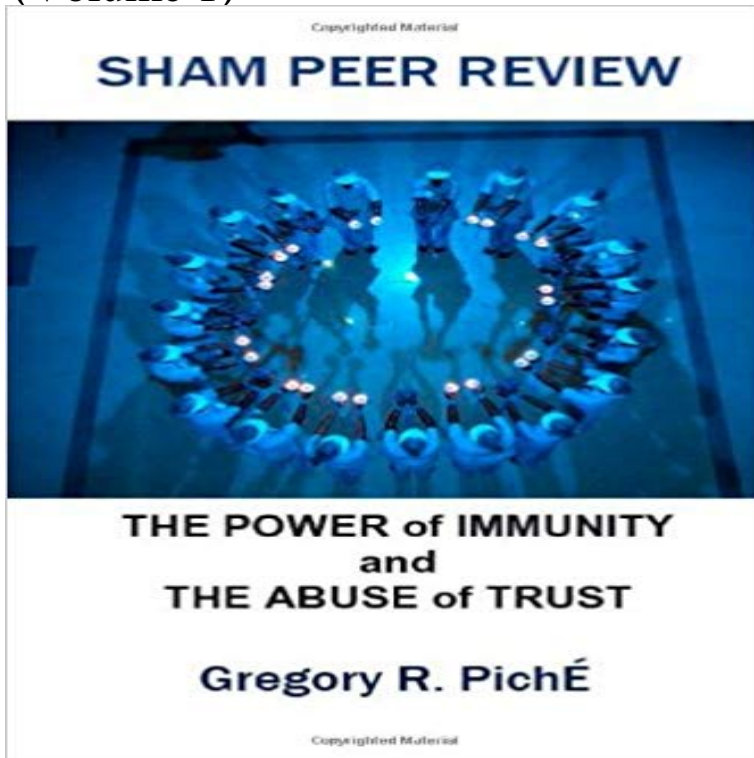


Sham Peer Review: The Power of Immunity and The Abuse of Trust (Volume 1)
