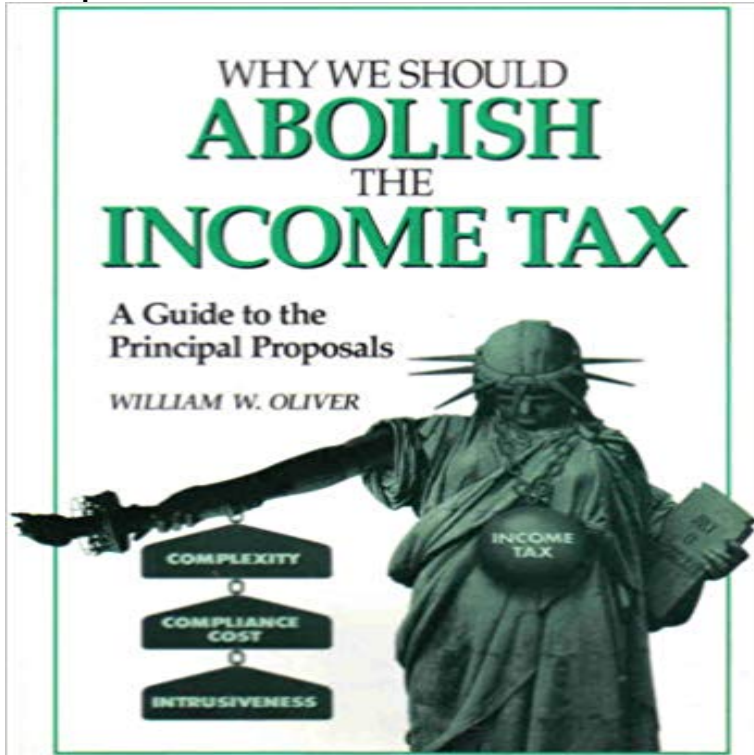


# Why We Should Abolish the Income Tax: A Guide to the Principal Proposals
