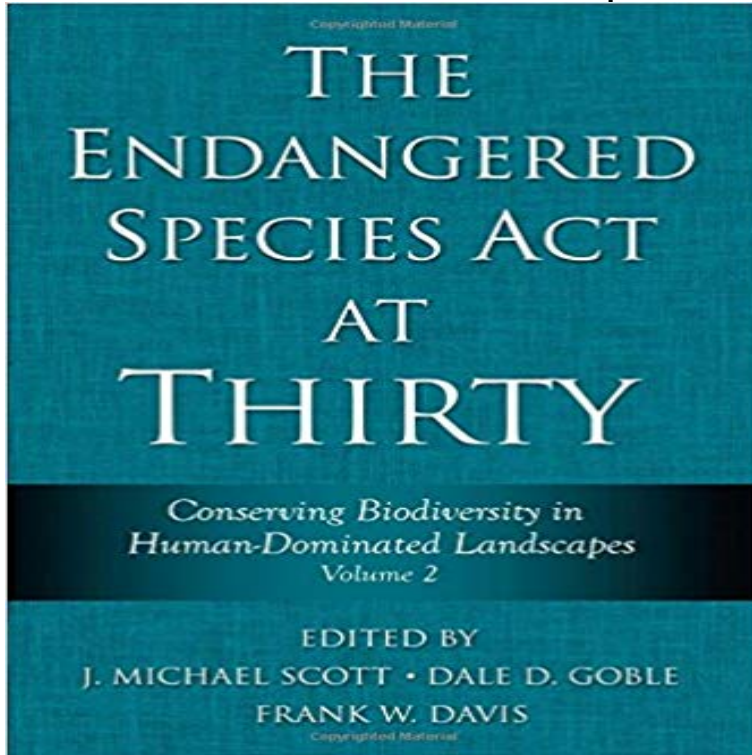


The Endangered Species Act at Thirty: Vol. 2: Conserving Biodiversity in Human-Dominated Landscapes
