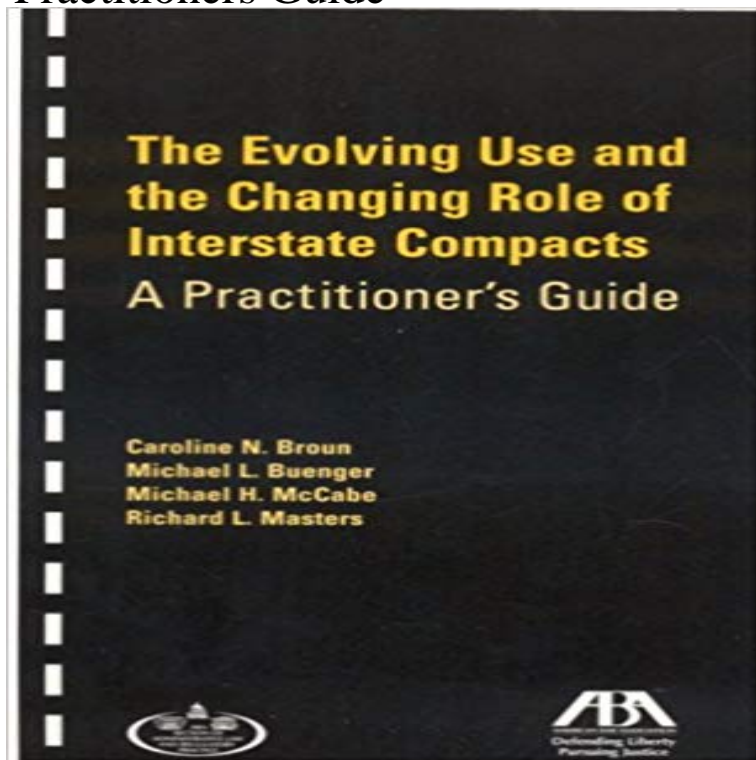


The Evolving Use and Changing Role of Interstate Compacts: A Practitioners Guide
