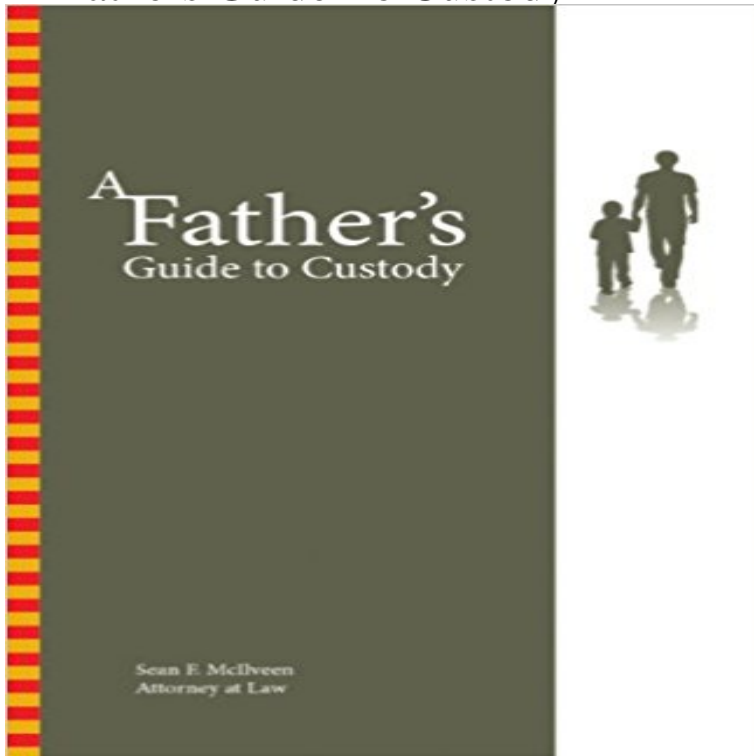


A Fathers Guide To Custody
