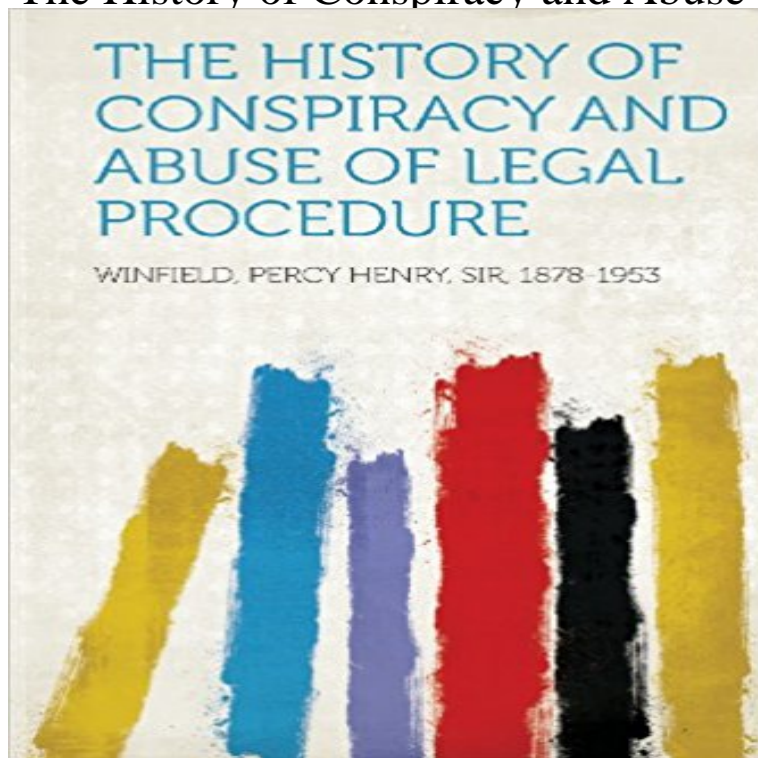


The History of Conspiracy and Abuse of Legal Procedure
