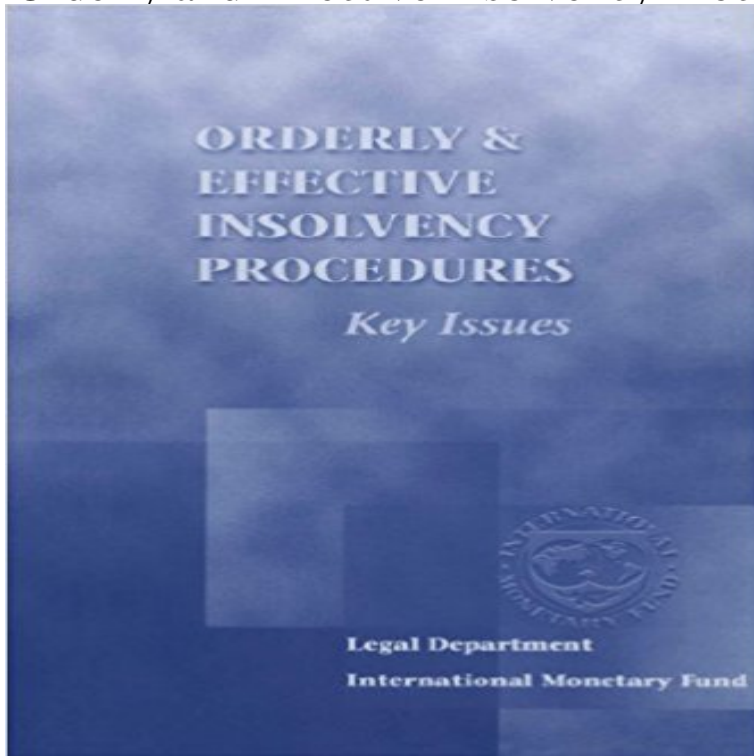


Orderly and Effective Insolvency Procedures
