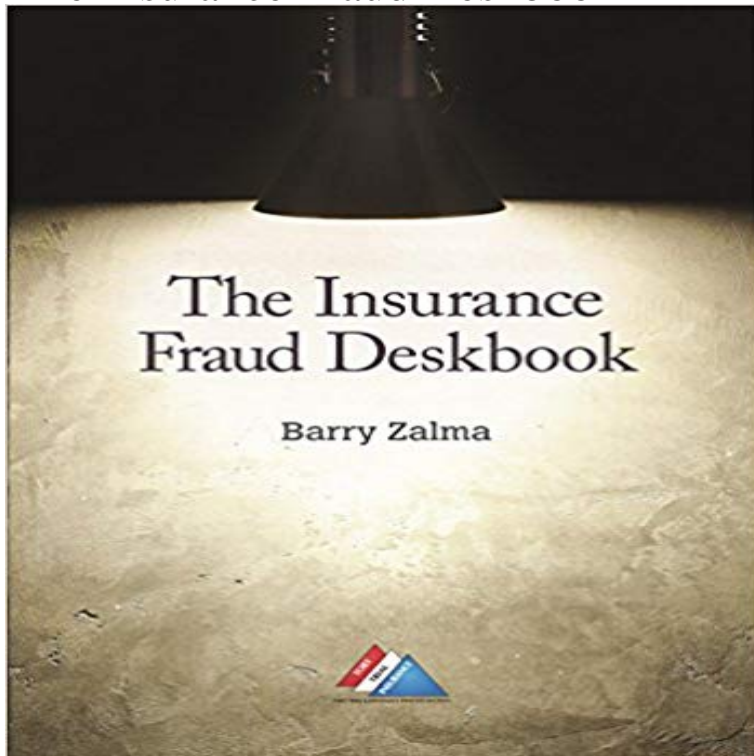


The Insurance Fraud Deskbook
