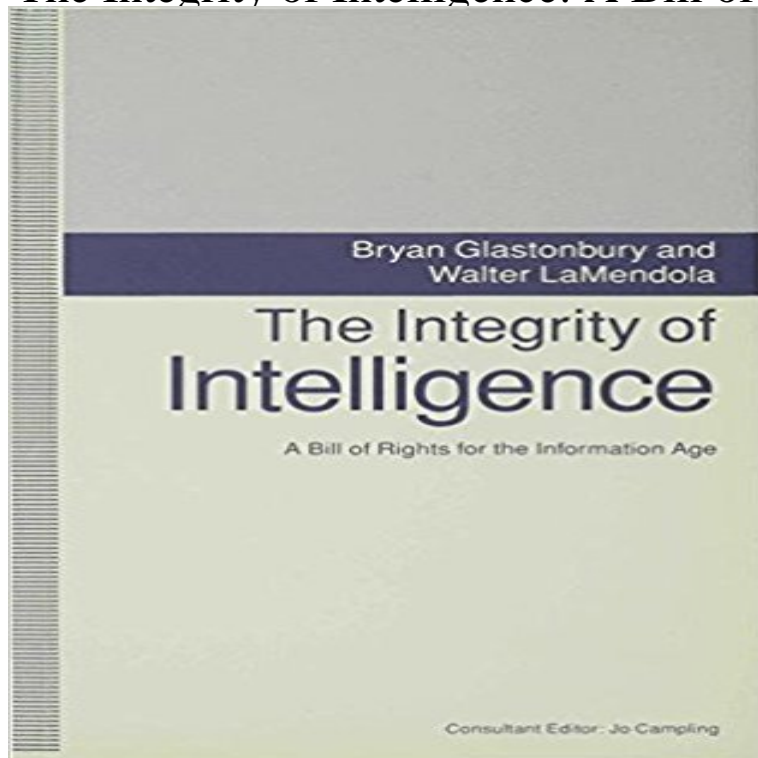


The Integrity of Intelligence: A Bill of Rights for the Information Age
