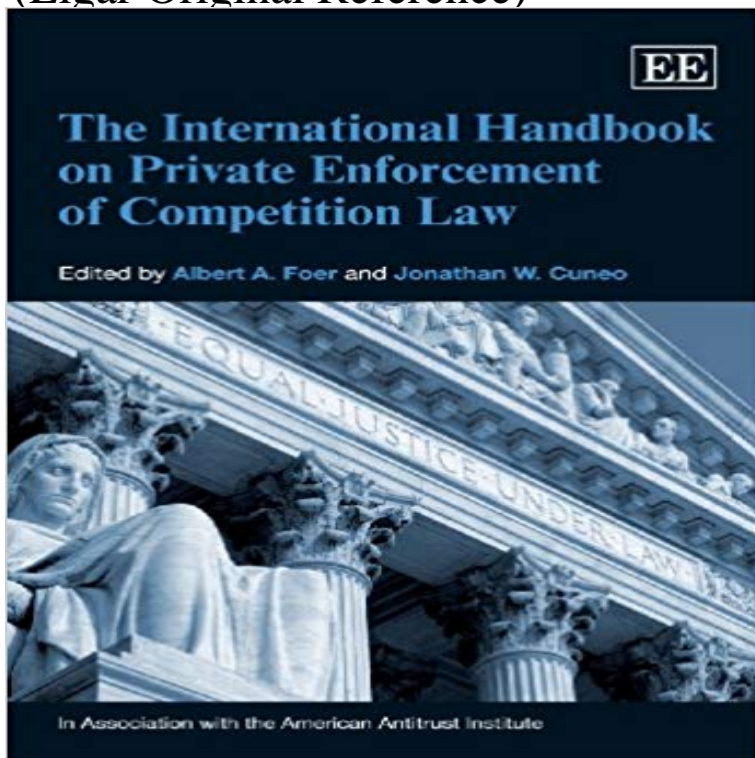


# The International Handbook on Private Enforcement of Competition Law (Elgar Original Reference)
