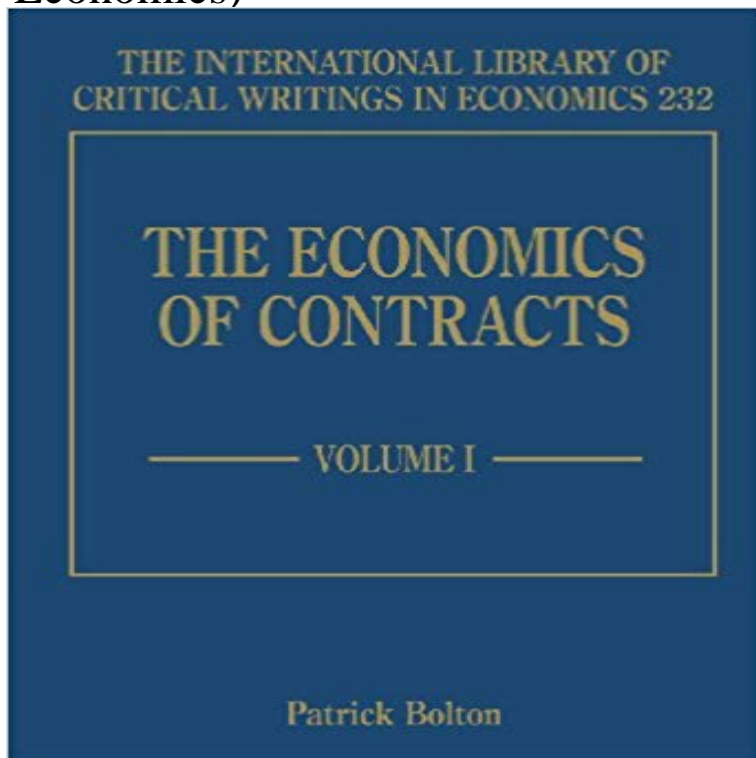


The Economics of Contracts (International Library of Critical Writings in Economics)
