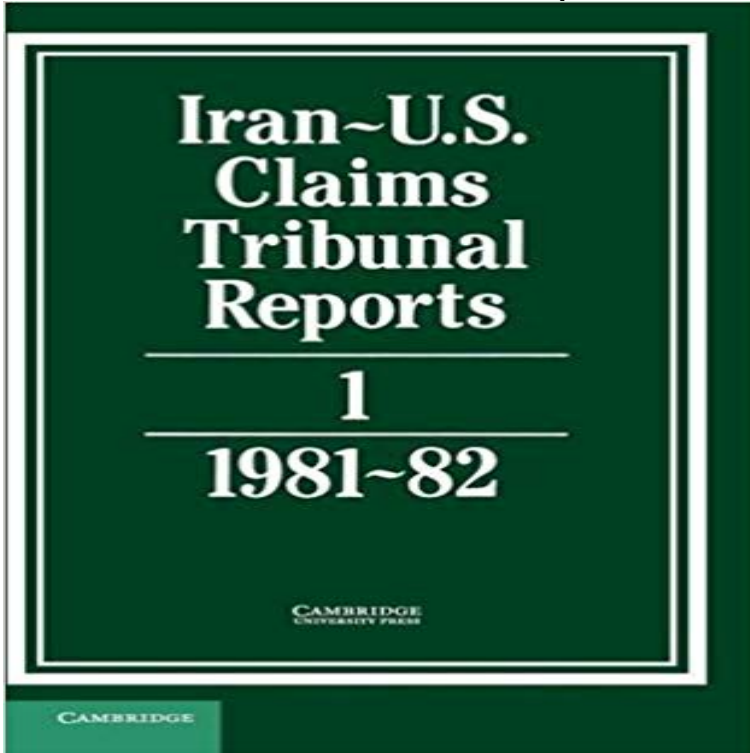


Iran-US Claims Tribunal Reports: Volume 1
