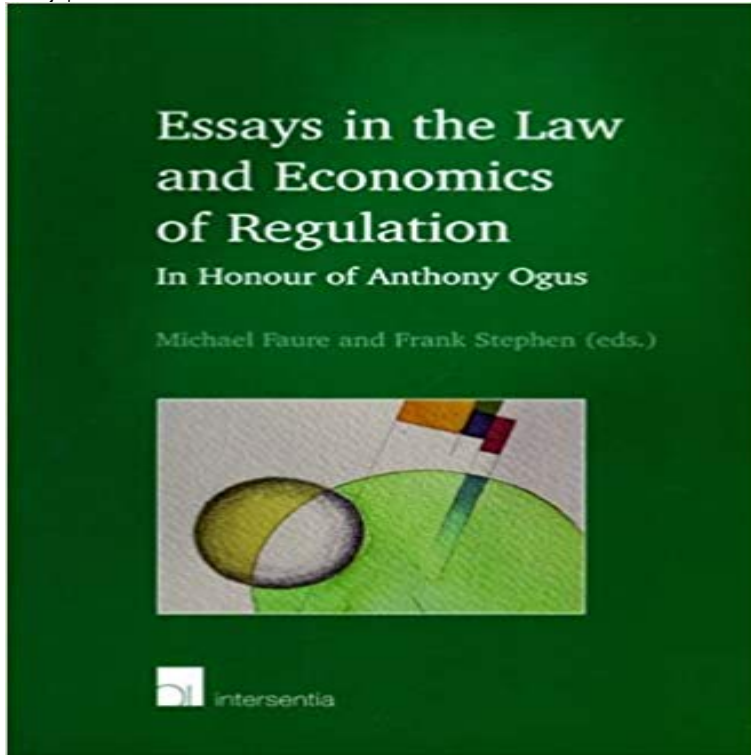


Essays in the Law and Economics of Regulation: In Honour of Anthony Ogus
