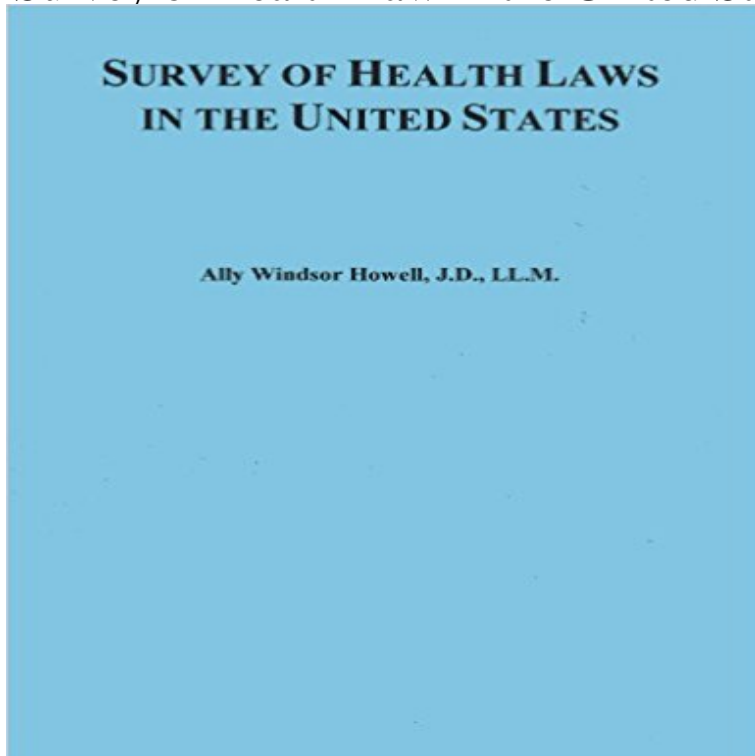


## Survey of Health Law in the United States
