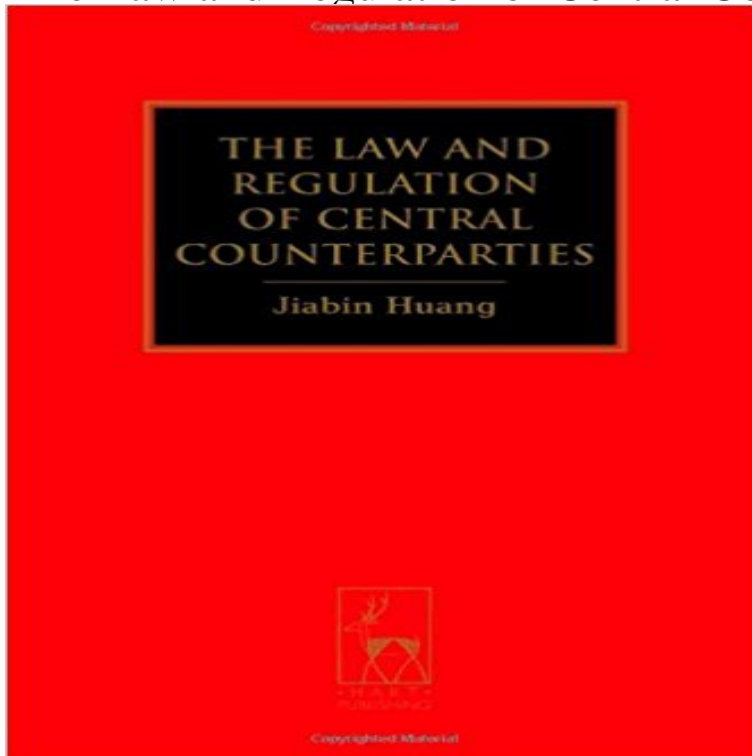


The Law and Regulation of Central Counterparties
