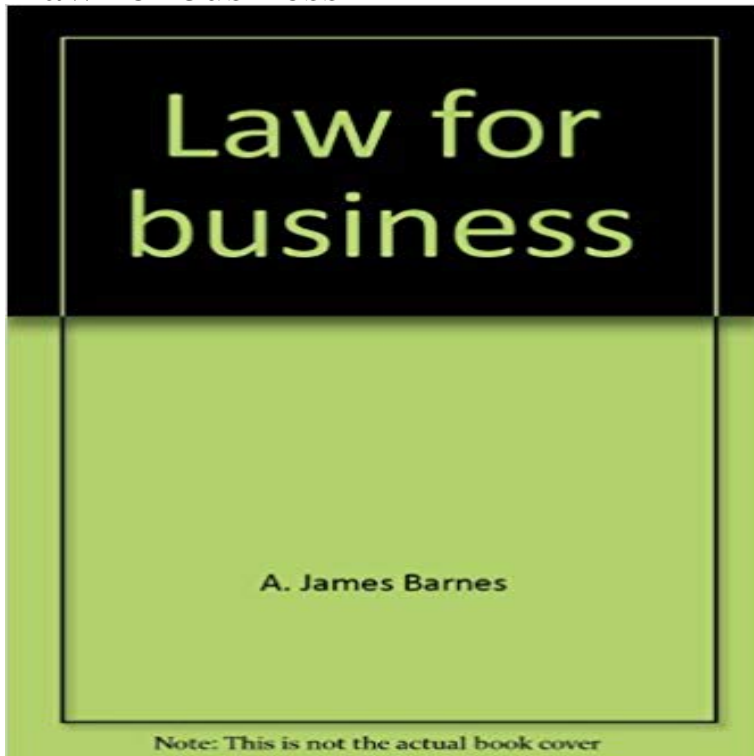


Law for business
