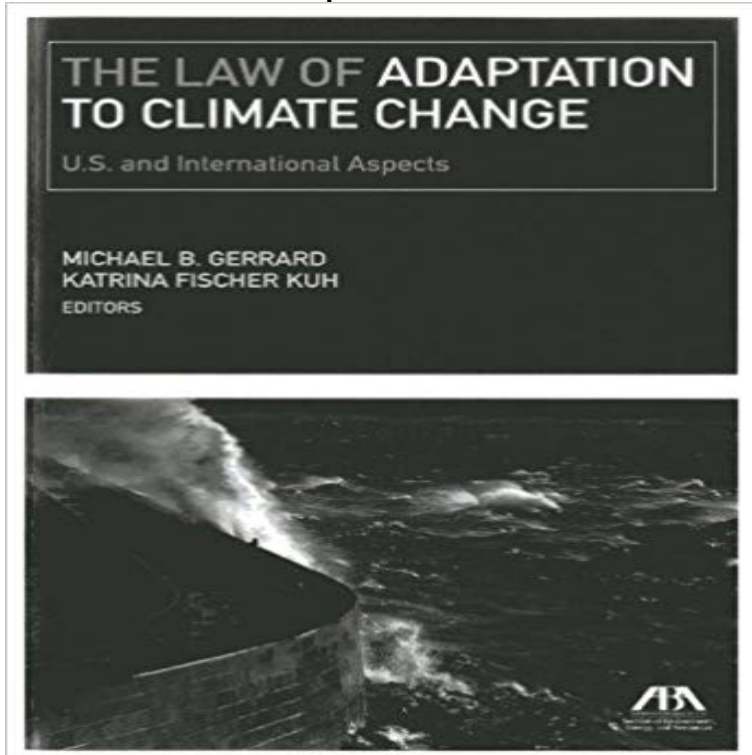


The Law of Adaptation to Climate Change: United States and International Aspects
