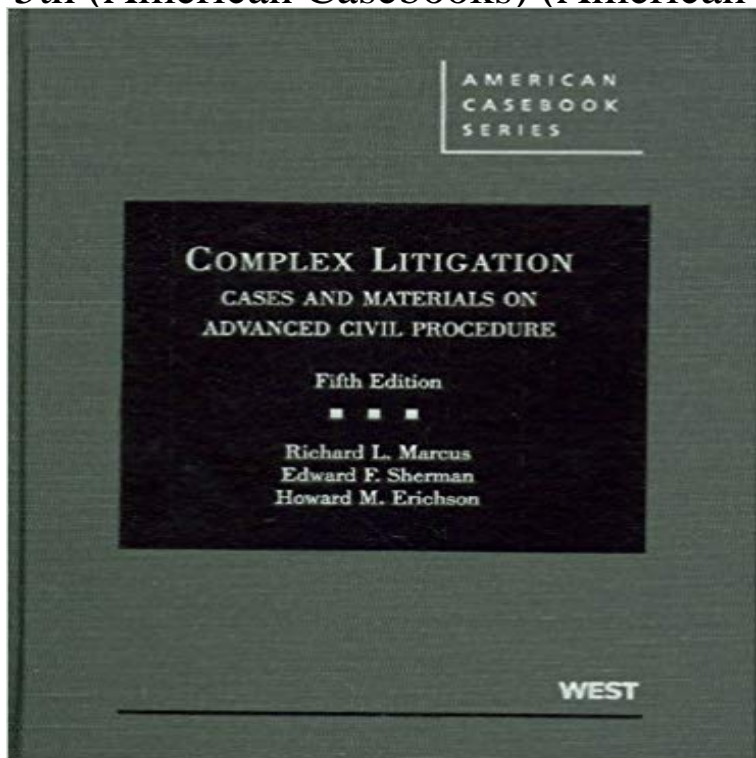


Complex Litigation, Cases and Materials on Advanced Civil Procedure, 5th (American Casebooks) (American Casebook Series)
