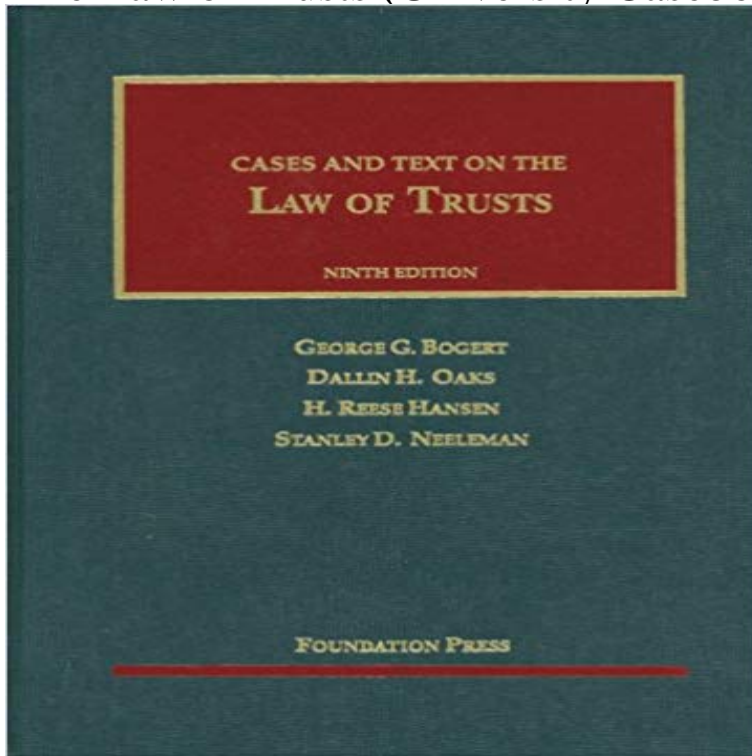


## The Law of Trusts (University Casebook Series)
