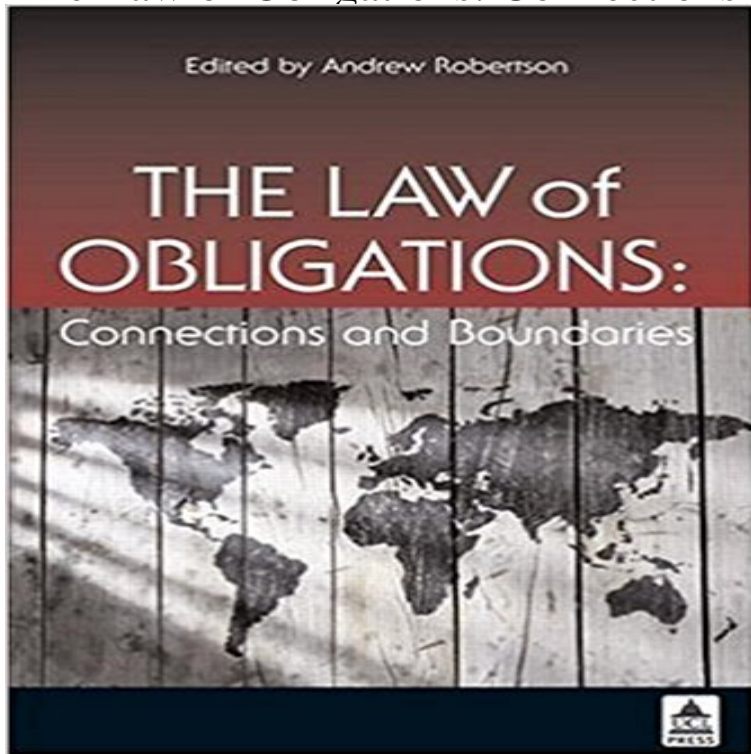


## The Law of Obligations: Connections and Boundaries (UCL)
