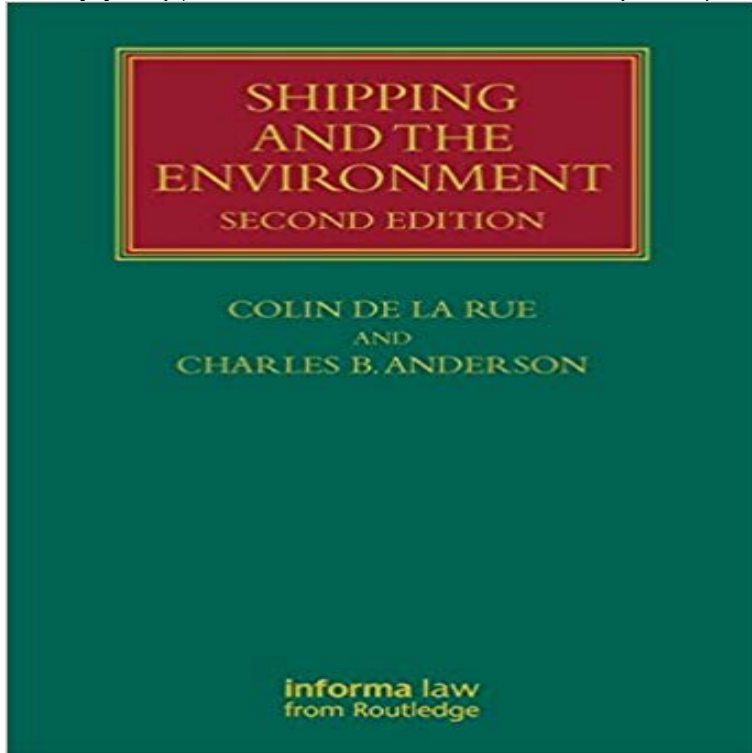


Shipping and the Environment (Lloyds Shipping Law Library)
