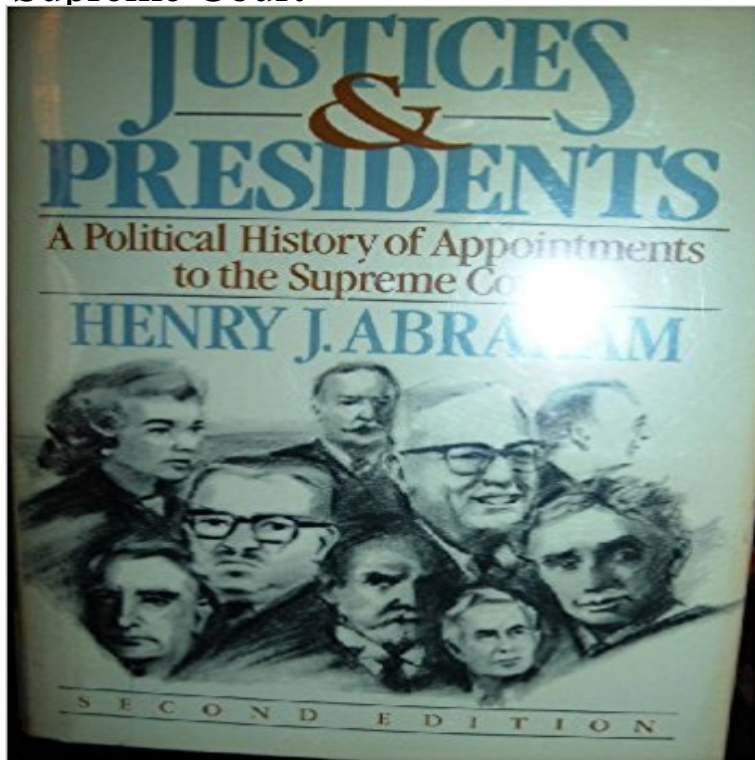


Justices and Presidents: A Political History of Appointments to the Supreme Court
