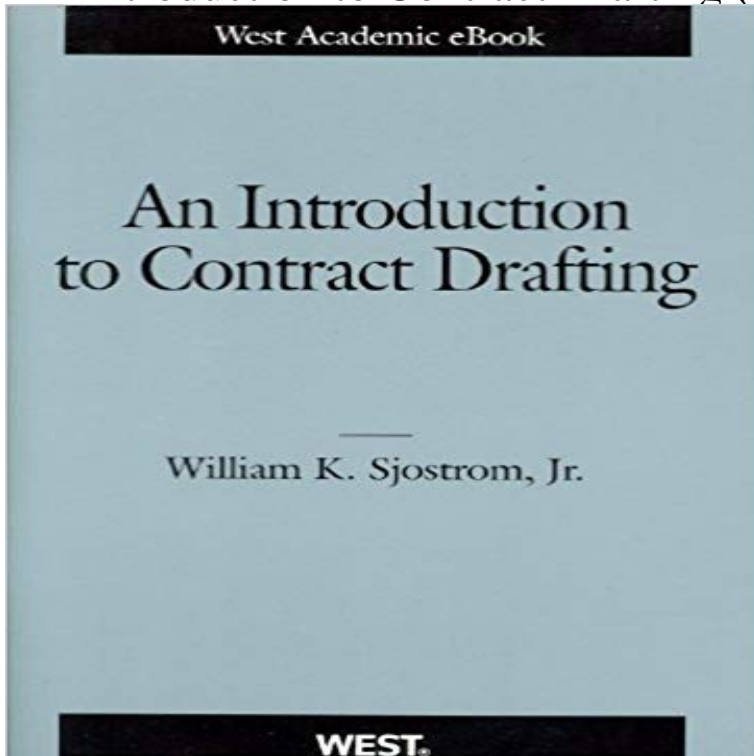


An Introduction to Contract Drafting (American Casebook Series)
