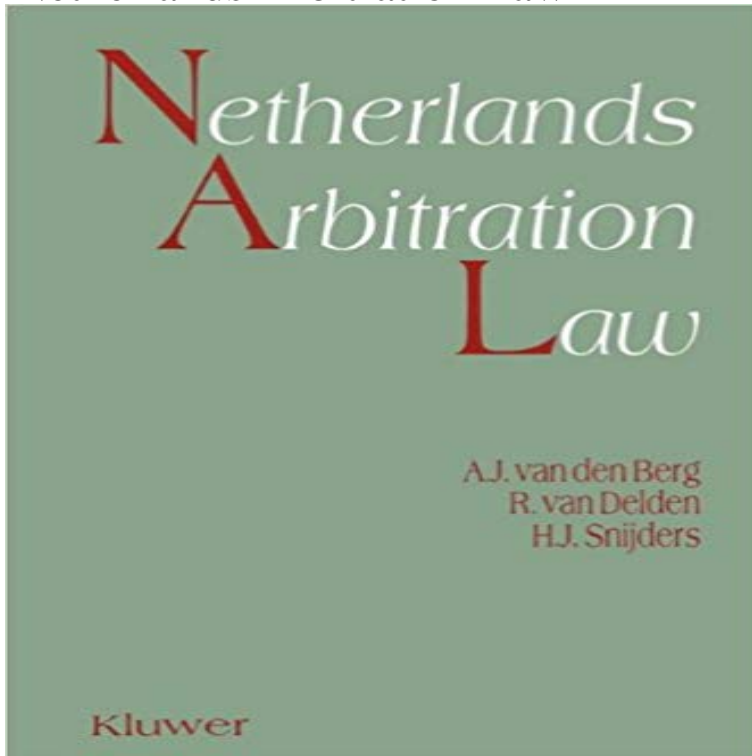


## Netherlands Arbitration Law
