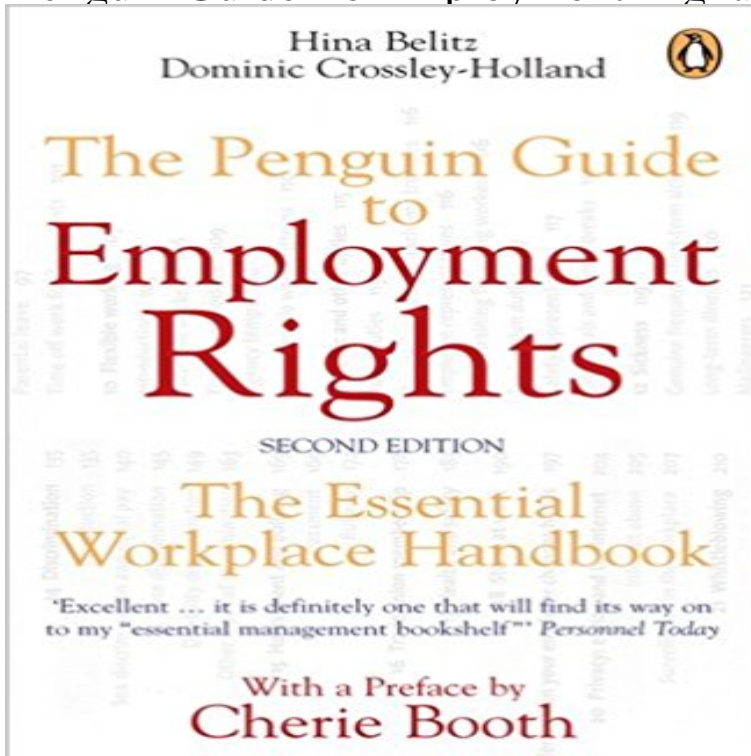


Penguin Guide To Employment Rights 2e
