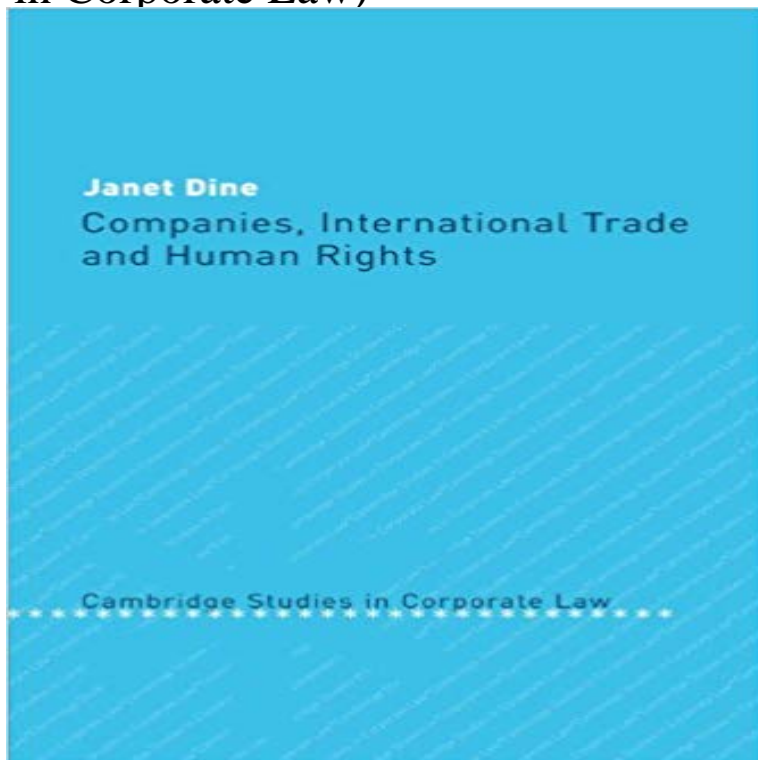


Companies, International Trade and Human Rights (Cambridge Studies in Corporate Law)
